Dear Election Authority:

This 2026 Primary Election Certification of Candidates and Party Emblems booklet contains the list of names and addresses of candidates entitled to be voted for at the August 2026 Primary Election. Party emblems for the three established political parties are also included. This Certification booklet is provided in accordance with Section 115.387, RSMo.

Mailing addresses for each candidate are also available on our website at www.sos.mo.gov. The primary ballot will consist of the candidates in this certification within your jurisdiction, as well as any candidates who have filed with your office.

As a local election authority, Missouri law requires you complete the following:

1. Publish Notice in Newspaper (Section 115.389, RSMo.): Upon receipt of this publication, you must publish, under proper party designations, the title of each office, name and address of each candidate to be voted on in your jurisdiction, primary election date, and hours the poll will be open in a newspaper of general circulation within your jurisdiction.
2. Prepare, Send and Post Sample Ballots (Section 115.391, RSMo.): You must prepare sample official ballots no later than the fourth Tuesday before the primary election. Immediately after preparing the sample ballots, you must mail the sample ballot to each candidate named on the ballot and to each county chairperson within your jurisdiction. You must also post a copy of each sample ballot in a conspicuous place in your office.
3. Ballot Preparation: Refer to Sections 115.237 and 115.395, RSMo., for ballot preparation requirements. Ballots must list the candidates in the order listed in this Certification booklet. Each candidate's name must be printed on the ballot in capital letters in not less than ten-point size. Section 115.395, RSMo., requires a separate ballot for each party participating in the primary election.

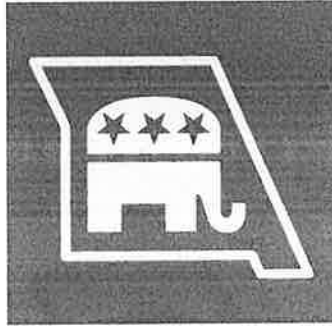

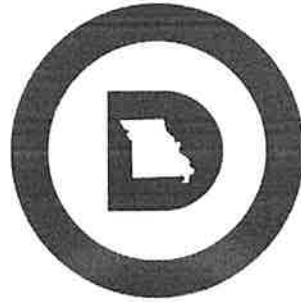
